#### 15 Description of Product

The Type F Float Switch comprises a cylindrical enclosure with a spigoted cover attached by four A4-80 stainless steel screws. It used the flameproof protection concept. The enclosure and cover can be cast or machined from brass or stainless steel.

The base which may be threaded or provided with a welding spigot for attachment to the process media, is drilled to house a stem tube containing up to four hermetically sealed reed switches or thermal switches, or a combination of both.

The switches are rated up to 250V a.c. or d.c. 3A. The stem tube is fully potted and the reed switches are actuated by an external float containing a magnet. The enclosure contains terminals, and an internal earth facility.

#### 17 Specific Conditions of Use

- 1. The plastic material of the floats is not static dissipative so is a potential electrostatic discharge risk. It should be cleaned only with a damp cloth and not be mounted in high airflow dust laden atmospheres.
- 2. The selected cable entries (whether gland or conduit) shall be suitably certified and shall be installed so as to maintain the enclosure's ingress protection of IP6X.
- 3. The cable and cable entries shall be capable of operating in an ambient temperature range of  $-50^{\circ}$ C to  $+100^{\circ}$ C.
